## ABOUT ACCESS JUSTICE BROOKLYN

Founded in 1990, Access Justice Brooklyn is an independent 501(c)(3) organization that provides high-quality, pro bono legal services and community education to our neighbors in need. Using the collective talents of our dedicated staff and volunteers, we help ensure a more accessible legal system and equitable Brooklyn. Our approach involves recruiting, training, and mentoring *pro bono* volunteers from a range of legal and finance backgrounds – a proven service model that we pioneered and have maintained and grown since our founding. Central to achieving our mission, this partnership with *pro bono* volunteers allows us to assist far more individuals than we could alone and gives us critical flexibility to address new legal issues as they emerge. The success of this model is evidenced by the positive results we achieve for thousands of Brooklynites: Last year our services benefitted over 15,100 individuals and families, made possible through the support of 253 *pro bono* volunteers who collectively contributed over 5,606 hours of service to the Brooklyn community. Through our intervention in foreclosure, bankruptcy, elder law, consumer debt, and family law matters, we also obtained over \$3.06 million in financial benefits and savings for our clients.

AJB staff and volunteers also participated in 24 community outreach events to reach nearly 790 community members, ensuring Brooklyn residents know their rights and making legal help accessible in our clients' communities.
